- ❖ Your **arrival** will be welcome from **3.00pm** You will be notified of the van number prior to arrival and the key will be in the van ( if you are going to arrive later than 5.00 pm please phone to advise on your expected arrival time. The key will be in the van
- ❖ You will be required to **vacate** your accommodation by **10.00** am on the morning of departure.
- ❖ **Bedding provided. We only make up beds that are required. BRING YOUR OWN TOWELS.**
- ❖ The Holiday Homes are let and furnished for the number specified and no exception can be made.
